### **Building Department**

Scott Williams reported that effective 7/1/18 per State Senate Bill 393 we are required to report certain new structures to the local Fire Dept and 911 Center.

Scott also discussed the unsafe building at 50 West belonging to Shawn Farrell who was presented with a notice to tear down building. He asked for a 6 month extension, which is expired. He has since sold the property. Attorney Richardson stated that the new land owner must be notified via US mail that the structure should be demolished immediately.

Commissioner Jessup seconded the motion. **Motion carried 3-0.** Crystal also stated their need for a Nurse and expressed her concern about hiring and keeping Nurses due to our salary constraints.

### Howard Services – Lawn Treatments for 2018 Season

Commissioner Huber made a motion to approve Howard Services proposal for lawn treatments for the 2018 season at the Hancock County Court House in an amount not to exceed \$999 to be paid out of Building Maintenance. Commissioner Jessup seconded the motion. Motion carried 3-0.

Commissioner Huber made a motion to renew the contract with Maximus for professional consulting services of Title IV-D for 2018 for use in 2020 with a flat rate of not to exceed \$5,900 and an additional reimbursement as a percentage of savings per the contract. Commissioner Jessup seconded the motion. **Motion carried 3-0.**
