Work Progress to date:

- I. Existing Facilities:
 - A. All REVIT models are complete. See attached.
- II. Surveys:
 - A. Surveying is in progress. Expected to be complete next week.
 - B. Research is being conducted regarding the deeds for the jail as they are non-taxable and it appears that there were several different parcels that probably have been acquired over time. Spring Street on the East side of the property was originally platted as an alley and apparently some of the original lots were vacated in order to establish Spring Street.
 - C. RQAW/RMA is working with the Auditor and Recorder to address any title search issues.
- III. Geotechnical Report:
 - A. Geotech drilling has been completed. The wells are being monitored for water infiltration data. The final report will be conducted this week and the holes patched.
- IV. Private Utility Locate:
 - A. Private utility locates for the site have been completed.
- V. Code Review:
 - A. Code reviews and research have determined compliant/economical ways to address high rise construction with I-3 (Jail Occupancy) without the need to fire rate the modular steel cells.

 - IX. Master Schedule and Budget Structure are in development


Work Progress anticipated over the next 2 weeks:
